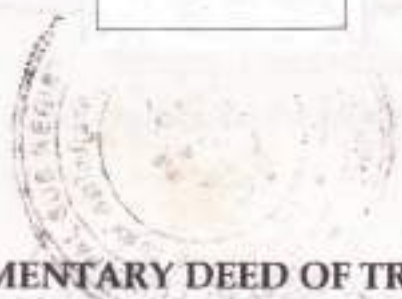





- C) As **Fr. CYRIAC THUNDIYIL CMI and Fr. CHACKO MANACKAL CMI** got transferred to the new places, the new President **Rev. Fr. JOSEPH VATTAPARAMPIL CMI** accepted the resignation of the above mentioned Trustees.

AND these additional clauses and amendments as well as those of Supplementary Deed of the Trust registered as No. 238 of 2014 are incorporated in the original deed of the Trust registered as No. 319 of 2009 for the benefit and welfare of the Trust and are made without any fear and favour to anyone other than the Trust. All other provisions and clauses provided in the above mentioned Original Deed of the Trust are still in full force and the changes and other clauses as per this Second Supplementary Deed shall form the part and parcel of the original deed.

The value of the Trust Fund is **Rs. 1,000/- (Rupees One Thousand only)** and a Stamp Duty of **Rs. 1,200/- (Rupees One Thousand Two Hundred only)** is charged under the Kerala Stamp Act for this deed.
